NO. 101 APPROVE MEETING MINUTES

COMMITTEE REPORT / DEPARTMENT REPORTS

Sgt. Matthew Palumbo reported that he canvassed the civil service list and supplied one candidate with a background packet. Officers are performing nightly building checks of the Town Hall. He is looking into a possible speed study of Dutch Hill Road.

Highway Superintendent Testa informed the board the David Strong is eligible for his probationary pay raise and reported that he will be pouring the concrete Thursday for the salt shed. He sold the New Holland Skid Steer at auction for \$36,000. He would like to purchase a bob cat.

He opened up an accounts payable at M&T Bank that will be used for BST accounting so funds can be transferred into the account and BST will use that for paying the town's bills.

MARIHUANA REGULATION AND TAXATION ACT FOR TOWN GOVERNMENT

Superiors Asnoe reported that the town has the opportunity to opt-out of allowing a retail store or a consumption store for cannabis, it has a 4% tax on it, 1% goes to the County and 3% goes to the towns, cities or villages. If there is Village in a town they can work out the percentage the town receives, if no agreement it is a 50/50 split. The town must adopt a local law by December 31, 2021 to opt-out. **TABLED**

MORITORIUM FOR SOLAR FARMS

Supervisor Asnoe reported that the eighteen (18) month moratorium on Solar Farms and Battery Energy Storage has expired and that the Local Law #1, 2021 Certain Solar Energy Systems and Equipment within the Town of Frankfort is now in effect.

REOPENING TOWN HALL TO THE PUBLIC**TABLED**

Supervisor Asnoe would like to reopen the Town Hall, he is waiting for the Town Justices to get back to him when they will be opening up the court. He doesn't want to open the Town Hall until, most of the foot traffic is for court and he doesn't want the other departments to have to deal with court issues. **TABLED**
