In consideration of the granting of this permit, the undersigned agrees:

1. To accept and abide by all provision of Chapter 29 entitled Building, Plumbing, Water Connections and Sewer Connection Permit Fees, and Chapter 73 entitled Streets and Sidewalks of the Code of Frankfort, and for all other pertinent ordinances or regulations that may be adopted in the future.
2. To maintain the water service lateral at no expense to the Town.
3. To notify the Town Codes Enforcement Officer when the water service lateral is ready for inspection and before the water service lateral is made.
4. To obtain a contractor who will be subject to town approval prior to commencement of construction.
5. To be responsible financially and otherwise for the restoration of the roadway for a distance of fifteen (15) feet from either side to the center of the excavation and to restore said roadway in like condition to that existing before construction, said work to be done under the supervision of the Department of Highways Superintendent. **Prior to construction, the applicant shall obtain an excavation permit from the Town Highway Superintendent and post sufficient bond and liability insurance as directed in Chapter 73 of the Town Code and any amendments applicable thereto.**

6. To be subject to inspection during construction by the Plumbing inspector (with his permission) prior to covering said work, and upon completion of road restoration, with written approval by the Superintendent of Highway and applicant agrees to notify the Town Codes Enforcement Officer as to completion.
