In consideration of the granting of this permit, the undersigned agrees:

1. To accept and abide by all provision of Chapter 70 entitled Sewers, Chapter 29 entitled Building, Plumbing, Water Connections and Sewer Connection Permit Fees, and Chapter 73 entitled Streets and Sidewalks of the Code of Frankfort, and for all other pertinent ordinances or regulations that may be adopted in the future.
2. To maintain the sewer at no expense to the Town.
3. To notify the Town Codes Enforcement Officer and Plumbing Inspector when the sewer is ready for inspection and connection to the sewer lateral, before any portion of the work is covered.

In consideration of the granting of the right to construct a sewer lateral from the public sewer system to the property herein list, the undersigned further agrees:

1. To accept and abide by all provisions of Chapter 70 of the Town Code, and in particular those sections pertaining to specifications for design, materials and installation and for all other pertinent ordinances or regulations that may be adopted in the future.
2. To obtain a contractor who will be subject to town approval prior to commencement of construction.
3. To obtain from said contractor an estimate of the total fee for labor and materials to construct the lateral only and to deposit with the Town Codes Enforcement Officer a sum of money to said estimate.

4. To be responsible financially and otherwise for the restoration of the roadway for a distance of fifteen (15) feet from either side to the center of the excavation and to restore said roadway in like condition to that existing before construction, said work to be done under the supervision of the Department of Highways Superintendent. Prior to construction, the applicant shall obtain an excavation permit from the Town Highway Superintendent and post sufficient bond and liability insurance as directed in Chapter 73 of the Town Code and any amendments applicable thereto.
5. To be subject to inspection by the Plumbing Inspector during construction prior to covering said work, and upon completion of road restoration and by the Superintendent of Highway and applicant agrees to notify the Town Codes Enforcement Officer as to readiness.
