COMMITTEE REPORTS / DEPARTMENT REPORTS

Various reports submitted and reviewed.

Chief Matthew Palumbo informed the town board that he set them Metro Count on Taft Ave. after seeing the petition from the residence. He stated that staffing is still an issue with part-time officers and department training has resumed since COVID. Chief Palumbo is requesting the town board increase STOP DWI funded patrols to pay rate of \$22.00 per hour and appoint Matt Darrow as Part-Time competitive police officer and Brandon Macera to full-time. He would like the board's permission to interview and hire a full-time officer

Highway Hwy Superintendent Testa thanked the Village of Frankfort Water Department for all the help on 1st Ave Ext. water break. He also reported that the salt truck is still not in; it's still waiting for parts. The Town Highway truck has a head gasket leak. He informed the town board that HEO Billy Smith is injured so he needs to hire a temp, at \$21.24 per hour

FINANCIAL REPORT

Supervisor Asnoe presented the financial report for September and balances of the current day deposit account to the town board. He stated that he is looking into certificate of deposit rates; if favorable he would like to take money out of the money market and put it into cd's. He also received the report for the Town's credit rating for Standard & Poor that the town's credit rating is now an A.
