COMMITTEE REPORT / DEPARTMENT REPORTS

Various reports submitted and reviewed

Chief Palumbo informed the town board that Mr. Rich Linder wanted to thank Officer Lou Romano going on and above and being so kind to his son's. He reported that Extreme Risk Protection order Law (ERPO) is now required by law, he stated that it is very time consuming and challenging. Chief Palumbo informed the town board that the new patrol vehicle will be finalized in January 2023; it is within he's budget and that there is no more state bidding. Chief Palumbo stated that he would like to hire Christopher Rooke as Full-Time Competitive Police Officer with all benefits and a pay rate of \$23.74 starting 1/17/2023.

Superintendent Testa wanted to acknowledge the good job his guys did during the snow storm, and there were only minor break downs. He wanted to clear up one of that Asrick Road never got dedicated to the Town of Frankfort; the paper work is all there it just needed to be signed by all the board members 15 years ago. Supervisor Asnoe asked Superintend Testa to get the file over to Attorney Karl Manne to review.

FINANCIAL REPORT

Supervisor Asnoe presented the financial report for November and balances of the current day deposit account to the town board.

ASSESSOR REPORT

Supervisor reported that the Assessor submitted her report and is asking the town board due a resolution for 467 property tax law for low income people, exemptions may be renewed on the town's 2022 assessment roll without a renewal application.

NORTH FRANKFORT BRIDGE
