**NO. 146 AUTHORIZING THE IMPLEMENTATION AND FUNDING OF THE COSTS OF 100% OF THE COST OF A TRANSPORTATION PROJECT, WHICH MAY BE ELIGIBLE FOR FEDERAL-AID AND /OR STATE-AID, OR REIMBURSEMENT FROM BRIDGE NY FUNDS**

**MOTION** made by Supervisor Asnoe that the town board resolves to approve the resolution authorizing the implementation and funding of the costs of 100% of the cost of a transportation project, which may be eligible for federal-aid and/ or state-aid, or reimbursement from bridge NY funds, for the rehabilitation of bridge over CSX/Amtrak and Mohawk River/Barge canal in the Town of Frankfort and Schuyler P.I.N. 2754.85.12 (Attached). **NO. 147 APPROVE EXTENSION OF LOCAL LAW #2, 2023; A SIX-MONTH MORATORIUM ON SOLAR ENERGY SYSTEMS WITHIN THE TOWN OF FRANKFORT**

**MOTION** made by Councilman Wallace that the town board approves a six-month extension on Local Law #2, 2023, extending a six-month moratorium within the Town of Frankfort. Second by Councilman Tamburro. Upon roll call; All in favor. Vote was 5-0 **APPROVED**

**NO. 148 APPROVE CONSOLIDATION OF VITAL REGISTRATION DISTRICTS BETWEEN THE TOWN OF FRANKFORT AND THE VILLAGE OF FRANKFORT**

**MOTION** made by Supervisor Asnoe that the town board to approve the Town Board of the Town of Frankfort that the consolidation of the Town and Village registrar functions under the Town's registration number (Vital Registration District 2153) is approved pending necessary approval of all other required entities, including Village of Frankfort, Herkimer County and New York State department of Health. Second by Councilman Perritano. Upon roll Call; All in favor. Vote was 5-0. **APPROVED**

**NO. 149 APPROVE FULL-TIME POLICE OFFICER—Kenneth R. Allen III**
