**COMMITTEE REPORT / DEPARTMENT REPORT**

Monthly reports from town clerk, codes, and police department were submitted and reviewed

**Police Department** Sgt. Matthew Palumbo, OIC reported that he is looking to take the 2014 Ford patrol vehicle out of service and auction it off. He send a memo out to all the Police Officers that he would like them to enforce the no parking on the town roads. Sgt. Palumbo report also that he is changing the ghost lettering on the 2017 Charger, he wants the lettering to be visible to the public.

**Hwy. Supt. Testa** reported that he met with FEMA and the State looking at storm damaged roads and writing them up for FEMA, to hopefully cover the cost. He still has not heard anything about FEMA covering the cost of Wilson.

**BROOKSIDE PUMP STATION**

Road. Hwy. Supt Testa report that the Brookside Drive Pump Station is complete and the water is hooked up. The Village of Frankfort is going to put up the pole for communication to the tank. Supervisor Asnoe reported that the town hired Tom Roman, NY Advanced Electric, Inc. to do the electrical connection on the pump station but ran into a snag. Tom is waiting to hear from Engineered Fluid, Inc. if the pump station can be changed from 3 Phase to a single phase. If that can't be done then the town will have to wait to hear from National Grid. Supervisor Asnoe report that the Board of Health said the tank does not have to be chlorinated. Once there is power to the building the chlorination the testing and getting the unit back on line from the people from Illinois, they have to be the ones to start up the unit per the contract.

**FINANCIAL REPORT**

Supervisor Asnoe reported that he asked for an extension for the AUD.

**WEST FRANKFORT WATER—USDA FUNDING (CENTER & ZOLAD ROADS)**

Supervisor Asnoe reported that he and Councilman Wallace met with USDA Rural Development and they gave the town a financing offer for \$765,000.00 at 2.25% interest for 38 yrs. And a grant for \$600,000.00 for a total of \$1,365,000.00. Supervisor Asnoe forwarded the offer to the engineers to see if the numbers fall within the parameters of what was told to the home owners as to what it would cost them (attached). Rural Water also said if the town gets the water quality testing done the numbers could change the town could get a bigger grant and possible a lower interest rate if it turns out there is contamination in the area. **TABLED**
